B104'S "TICKET STOP – TAILGATE N TALLBOYS" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. <u>Remote Broadcast</u>: Attend a remote broadcast conducted by Station on May 28, 2024 from 4:00pm CT through 6:00pm CT at Run N Erin's (1107 W. Locust St., Bloomington, IL 61701) and complete an entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.

- 4. **Winner Selection.** On May 28, 2024 at approximately 5:00pm, 5:30pm, and 6:00pm CT, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant must be present to win. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.
